

A Câmara de Internacionalização e Mobilidade informa que, devido ao COVID-19, a ETS disponibilizou uma nova versão dos testes de proficiência *TOEFL iBT®* e *GRE®* General Test para serem realizados nas próprias residências dos interessados e não mais de forma exclusiva nos Centros Aplicadores, de forma presencial.

Com essa decisão, aqueles que já possuem agendamentos nos Centros Aplicadores poderão solicitar a mudança de data e de formato, sem custo adicional. Aos que não fizeram o agendamento, nem o pagamento, e têm interesse em fazer os testes, poderão realizá-los de suas próprias residências, conforme comunicado a seguir:



ETS is pleased to announce expanded availability of at home testing for the *TOEFL iBT®* test and *GRE®* General Test. The tests will now be available in all locations where the computer-delivered tests are normally available, with the exception of Mainland China and Iran. In Mainland China, ETS is working closely with the National Education Examinations Authority to accommodate test takers impacted by test cancellations, including adding test dates once regular testing resumes. We are working to offer at home testing in Iran as soon as possible.

Early-day response from both test takers and institutions has been very positive. In fact, since last week's launch, more than 7,000 test takers successfully registered to take either the *TOEFL iBT* Special Home Edition or the *GRE* General Test at home, with 500 students already successfully completing their tests. While currently there is sufficient capacity for students to register immediately and test a few days later, we suggest that you encourage prospective students to register as soon as possible for the best chance to secure their preferred date and time.

If you haven't already, we hope you'll join us for a webinar about the at home tests. We'll offer a brief presentation and then hold a Q&A session. Questions that cannot be answered during the webinar due to time constraints will be answered via email afterward. [Learn more and register](#) for an upcoming event.

It is a free, online service that makes it easy for institutions to access score reports and test taker photos, listen to 1-minute samples of *TOEFL iBT* Speaking responses and view actual *GRE* Analytical Writing essay
